Acuité has downgraded the long term rating to '**ACUITE B+**' (**read as ACUITE B plus**) from '**ACUITE BB-**' (**read as ACUITE double B minus**) and reviewed the short term rating of '**ACUITE A4**'(**read as ACUITE A four**) on the Rs.20.00 Cr bank facilities of Zamindara Timber Private Limited(ZTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

The ZTPL is Haryana based company established in 1975 as proprietorship concern by Mr. Amit Kamboj and Mr. Sailash Kamboj. Later in the year 2013, the constitution of the company was changed into private limited. The company is engaged in sawing and trading of timber.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
