Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) and has reaffirmed the short term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.52.00 crore bank facilities of Sri Textile Erode Private Limited (STEPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Tamil Nadu-based, Sri Textile Erode Private Limited (STEPL) (formerly known as Sri Textiles) was established in 1990 as a proprietorship firm and converted to private limited in 2008. The company, promoted by Mr. Sengodan Vengadesan and Mrs. Venkatesan Padmavathy, is engaged in the manufacturing of fabrics and readymade garments at Tamil Nadu. STEPL has two manufacturing facilities each for garments and fabrics.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
