Rating Rationale

Acuite has reaffirmed the **long-term rating of 'ACUITE B+' (read as ACUITE B Plus)** and **short-term rating of 'ACUITE A4' (read as ACUITE A four)** on the Rs. 20.00 Cr bank facilities of Blue Whale Machinery Technologies Private Limited (BWMTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in November 2007, Blue Whale Machinery Technologies Private Limited (BWMTPL) is a Bangalore based company engaged in trading and servicing of construction equipments like horizontal directional drillers, micro-tunnelling, etc. and other construction equipments and also provides tools and accessories for the same. The promoter, Mr. Deepak D Mehta has an experience of more than a decade in this line of business.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
