**The issuer did not co-operate; based on best available information.

Acuite has reviewed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.00 crore bank facilities of Motilal Dhoot Infrastructure Private Limited (MDIPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Motilal Dhoot Group started by late Shri. Motilal Dhoot to execute irrigation department and other government department projects is currently serving customers in the following sectors: infrastructure, stone crushing and ready mix concrete. Incorporated in 2006, the company is engaged in the development of road and concrete projects in Pune primarily with Government agencies.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
