Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 9.88 crore bank facilities of Shiva Wheels Private Limited (SWPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Shiva Wheels Private Limited (SWPL) was incorporated in 2003 before which it was a partnership firm. It is based in Kolkata, West Bengal. The current directors are Mr. Sanjib Paul, Ms. Gouri Rani Paul, Mr. Kausik Paul, and Mr. Souvik Paul. The company is engaged in the dealership of motor vehicles of Honda for the last 8 years. It was engaged in dealership of ancillary auto parts before it. It has showrooms and a service centre at present in Kolkata and plans to inaugurate another service centre in Birati.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
