## Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs.5.00 crore bank facilities of Thermoset Poly Products India Private Limited (TPPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

## About the Company

Raigarh based, Thermoset Poly Products (I) Pvt Ltd. (Thermoset), established in 1993, is promoted by Mr. Jitendra Amrutlal Shah, Mr. Atul Shah, and Mr. Miten Shah among others. It is engaged in manufacturing of FRP/GRP manhole covers, STP tank covers and Overhead tank covers from synthetic resin, sand and fibreglass under the brand name of "Thermodrain". The company has a manufacturing facility located at Panvel, Raigarh.

## Non-cooperation by the issuer/borrower:
