**Rating Rationale**

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 12.50 crore bank facilities of Keen and Core Developers (KCD). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

**About the Company**

Delhi based, Keen and Core Developers (KCD) was established in 2008 as a proprietorship firm by Mr. Satyabeer Singh. The firm undertakes civil construction contracts for the construction of roads and buildings for the state governments of Madhya Pradesh and Uttar Pradesh.

**Non-cooperation by the issuer/borrower:**

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
