Acuité has reviewed the long-term rating of '**ACUITE B+** (**read as ACUITE B plus**) on the Rs. 6.10 crore bank facilities of JMG Automobiles. This rating is now an indicative rating and is based on the best available information.

Established in 1999, JMG Automobiles, partnership firm, is a dealer of Hero Motocorp Ltd two-wheelers bikes and scooters managed by Mr. Satyanarayan Agarwal and Mr. Pradeep Agarwal. Mr. Satyanarayan Agarwal retired as a partner in fiscal 2017 and new partner Mrs. Shipra Jain joined the board. Profit-sharing ratio among Pradeep Agarwal and Mrs. Shipra Agarwal is 51:49, respectively.

JMG Automobiles have few sub-dealers under it located in various parts of Cuttack. It also owns two service centres and sales spare parts and other ancillary items.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
