Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of Sivasakthi Engineering Company (SEC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sivasakthi Engineering Company (SEC) , a Bangalore-based partnership firm established in 1979 by Mr. R K Kaleswaran and his family is engaged in the manufacturing of open-top barrels and loop barrels. The firm has two manufacturing units at Bangalore and Ranipet with an installed capacity of around 1500 barrels per day.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
