Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (**read as ACUITE B plus**) on the Rs.10.00 crore bank facilities of Uttam Tools (UT). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Uttam Tools (UT) is a Pune-based proprietorship concern established in 1997 by Mr. Uttam Telge. The firm manufactures cutting tools and caters mainly to the automobile industry.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
