Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB-**' (read as **ACUITE Double B minus**) and the short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.16.40 Cr. bank facilities of Nithyabharath Textile Private Limited (NTPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Nithyabharath Textile Private Limited (NTPL) set up as a partnership firm in 1970, by Mr. Thangavell and his father in Tamil Nadu, it was converted to a private limited company in 2004. It is engaged in the manufacture and sale of grey fabrics of cotton/viscose and cotton polyester. NTPL operates 48 sulzer looms and 40 airjet looms with a total production capacity of 37,000 meters per day. The capacity utilization is about 90 – 95 per cent.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit ratings are based.
