Rating Rationale

Acuite has reaffirmed the long term rating to '**ACUITE B+**' (read as **ACUITE B Plus**) on the Rs.10.00 Cr. bank facilities of Krishna Beads Industries (KBI). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Established in 1970 as a partnership firm, Krishna Beads Industries (KBI), is engaged in manufacturing of bags, imitation jewellery, scarves, etc. for various international companies like Forever 21, Zara, Primark, Euro Fashion, etc. KBI has its plant in Mumbai and Noida. The partners are Mr. K.G. Maheshwari and his spouse Mrs. Rani Maheshwari.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
