Acuite has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B**) on the Rs. 50.00 crore bank facilities of KNK Ship Management (KNK). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

KNK, a Mumbai-based partnership firm, was established in 2015 by Mr. Capt. Naresh Kalra, Mrs. Prabhat Shobha Kalra, Mr. Devesh Kalra and others. The firm began operations as a proprietorship firm in 1989. It was led by Capt. Naresh Kalra, the firm provides ship management services such as time charter, manpower and recruitment, delivery and voyage, salvage and towing among others. KNK is a certified marine recruiting agent.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
