Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 5.00 crore bank facilities of Anandi Marketing (AM). This rating is now an indicative rating and is based on best available information.

The Hyderabad-based proprietorship firm Anandi Marketing was established in 2015 by Mr Akhilesh Vyasa. The firm is engaged in the trading of TMT rods, sponge iron, cement and coal.

Non-cooperation by the issuer/borrower:
