Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B' (read as ACUITE B) on the Rs. 5.22 crore bank facilities of Firma Cotton Industries. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Gujarat based, Firma Cotton Industries (FCI) was established in 2007 by Mr. Manjurali Yusufbhai Patel and his relatives. It is engaged in ginning and pressing of raw cotton and crushing of cotton seeds with a total installed processing capacity of 300 bales per day. It majorly caters to spinning mills and traders situated in Gujarat, Maharashtra, amongst others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
