Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 5.22 crore bank facilities of Firma Cotton Industries (FCI). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

The Gujarat based, Firma Cotton Industries (FCI) was established in 2007 by Mr. Manjurali Yusufbhai Patel and his relatives. It is engaged in ginning and pressing of raw cotton and crushing of cotton seeds with a total installed processing capacity of 300 bales per day. It majorly caters to spinning mills and traders situated in Gujarat, Maharashtra, amongst others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
