#### Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B**' (**read as ACUITE B**) on the Rs.6.00 crore bank facilities of Aceso Pharma (AP).The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Incorporated in 2016, Aceso Pharma (AP) is a Bangalore based proprietorship concern engaged in manufacturing of ayurvedic medicine and cream in the form of a capsule, ointment, syrup, powder, etc. The company operations began in FY 2018-19.AP is managed by Mrs. Padmini D.K

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
