Acuite has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 20.00 crore bank facilities of Maloo Industries (MI). This rating is now an indicative rating and is based on best available information.

Maloo Industries (MI) was established in 1997 as a proprietorship concern and the constitution was changed to partnership firm in 2015. The firm is currently promoted by Mr. Suyash Maloo and Mrs. Sandhya Maloo. Based out of Indore, the firm is engaged in cotton ginning, pressing, and export.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
