Rating Rationale

Acuité has reaffirmed the long term rating to 'ACUITE B' (read as ACUITE B) and the short term rating to 'ACUITE A4'(read as ACUITE A four) on the Rs.11.00 Cr bank facilities of Ti Anode Fabricators Private Limited (TAFPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is reaffirmed on account of information risk.

About the Company

Established in 1992 by Mr. V.P. Jeyakumar, Ti Anode Fabricators Private Limited (TAFPL) is engaged in manufacturing of engineering and electro chemical equipment such as cathode protection anodes, platinized titanium anodes, electrolyzers, chlorinators, HHO Generator and among others. The company has a facility located in Tambaram (Chennai).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
