Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+** ' (read as **ACUITE B plus**) and short term rating to '**ACUITE A4**' (read as **ACUITE four**) on the Rs. 24.50 crore bank facilities of Pritika Autocast Limited (PAL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Pritika Autocast Limited is promoted by Mr. Raminder Singh Nibber & Harpreet Singh Nibber. The Company is engaged in Manufacturing of machined castings and forging for tractor /automobile manufacturers in India. Pritika Autocast Ltd is flagship Company of Pritika Group of Industries which is a manufacturer of machined casting and forging in North India.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
