The trust is engaged to conduct religious programmes for the benefit of its members, general public and for the benefit of the whole of India. The trust conducts wide range of activities catering to the spiritual, cultural, charitable, community welfare and artistic interests of the people in and around North and West part of Bangalore.

Non-cooperation by the issuer/borrower
