Acuite has reviewed long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and short term rating of '**ACUITE A4+**' (read as '**ACUITE A four plus**') on the Rs. 16.50 crore bank facilities of Genisys Information Systems India Private Limited (GIPL). This rating is now an indicative rating and is based on best available information.

Established as a proprietorship concern in 1985, GIPL, part of the Genisys group, was reconstituted as a private limited company in 2005. Promoted by Mr. Ashokumar J. Rabheru and Mrs. Harshida A. Rabheru, the company is engaged in providing software services, consulting and business process outsourcing (BPO). The other group companies include Genisys Software Limited (UK) and Genisys Software Limited (USA).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
