Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE B+' (read as ACUITE B+) and short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 6.27 crore bank facilities of Aland Ceramic Private Limited (ACPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

ACPL, a Gujarat-based company incorporated in 2014 is engaged in the manufacturing, sale and export of ceramic and digital wall tiles since September 2015. The company is promoted by Mr. Kantilal Vadaviya and Mr. Hirenbhai Vadaviya with manufacturing unit located at Matel, Rajkot. ACPL exports its products to Israel, Iraq and Saudi Arabia.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
