Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A4**) on the Rs. 10.33 crore bank facilities of Versatile Glass Solutions LLP (VGSL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Versatile Glass Solution LLP is a limited liability partnership based out of Ahmedabad. The firm, established on April 2017 by Partners, Mr. Jaykumar Ashwinkumar Patel, Mr. Ruchit Dilipkumar Vyas and others is engaged in the manufacturing of toughened, laminated and insulated glass. The operations are expected to commence in April 2018. The firm caters to clients from across industries including aviation, commercial ports, hotels, defence and households.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
