Rating Rationale

Acuité has downgraded the long term rating to '**ACUITE B+** (**read as ACUITE B plus**) from '**ACUITE BB-** (**read as ACUITE double B minus**) on the Rs.20.00 crore bank facilities of Sumangalam Developers (SD). This rating is now an indicative rating and is downgraded on account of information risk.

Rajasthan-based, Sumangalam Developers is a partnership firm established on 8th July, 2015. It is part of the Sumangalam Group which was established in 2001. The group is engaged in the real estate business and has developed several residential and commercial projects. Led by Mr. Ishwar Lal Saini, it has recently completed the construction of a multi-storied residential project 'Shubh Atlantis' at Kota, Rajasthan.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
