Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB**' (read as **ACUITE double B**) and reaffirmed the short-term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs. 57.11 crore bank facilities of Jaybee Laminations Private Limited (JBPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Based in Noida, Uttar Pradesh, JBPL was incorporated in 1988 by Mr. Munish Aggarwal. The company is engaged in manufacturing of CRGO (cold-rolled grain-oriented) steel laminations and transformer cores used in distribution and power transformers. The company has two manufacturing units located in Noida and Greater Noida. JBPL has a geographically diversified customer base including Crompton Greaves, BHEL Limited and Voltech Manufacturing Company Limited, among others.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
