Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 6.50 crore bank facilities of Shri Paliwal Cattle Feed Private Limited (SPCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Shri Paliwal Cattle Feed Private Limited, a Rajasthan based company, was incorporated in the year 2016 as a private limited entity by Mr. Narendra Kumar Paliwal and Mr. Shanti Lal Paliwal. The company, however, started its operations in the month of November 2016. It is mainly engaged in manufacturing of cattle feed.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
