Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 29.50 Cr. bank facilities of J D Sons Steels Private Limited (JDSSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Haryana-based, J D Sons Steels Private Limited was incorporated in the year 2001 by Mr. Darshan Goyal and Mr. Vinod Goyal. The company is primarily engaged in the manufacturing of cold-rolled carbon strips and coils, and mild steel wires. The key promoter, Mr. Goyal, has been in the iron and steel industry since 1971.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
