Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed short-term rating to '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 7.20 crore bank facilities of Encore Projects Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

The Chhattisgarh based, Encore Projects Private Limited (EPPL) was established in the year of 2009 by Mr. Nitin Supe, Mr. Subodh Joshi and Mr. Malay Jain and is engaged in fabrication of steel with an installed capacity of 500 ton per month. The manufacturing plant is located in Bhilai, Chhattisgarh. The company caters to different industries such as sugar, steel, power and coal, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
