Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.24 crore bank facilities of Vedam Milk Product. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

The Tamil Nadu-based, Vedam Milk Product was established in 2016 by Mr. N Ramesh, Mr. N. Suresh, Mrs. S. Maheswari and Mrs. R. Rekha. The firm is engaged in the trading of milk and plans to commence production of dairy products including ghee, paneer, packaged milk among others from April 2018. The estimated project cost is Rs. 9.00 crore (including machinery cost of Rs. 7.80 crore and factory building of Rs. 1.20 crore).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
