Acuité has downgraded the long term rating to '**ACUITE B+ (read as ACUITE B plus)**' from '**ACUITE BB- (read as ACUITE double B minus)**' on the Rs. 10.00 crore bank facilities of Ram Meenakshi Firm (RMF). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Madurai, Tamil Nadu based RMF, is a partnership firm established in 1987 by Mr. V. Anbu chezhian and Ms. V. Keerthi Meena. The firm is engaged in the trading of pulses such as long-grain rice, moong dal, soya bean, to name a few.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
