Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 20.00 crore bank facilities of Patodia Ginning Factory (PGF). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

Maharashtra based, Patodia Ginning Factory (PGF) was established in the year 2003 by Mr. Mahesh Kumar Patodia. The firm is primarily engaged in ginning and oil extraction.

Non-cooperation by the issuer/borrower:
