Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.6.53 crore bank facilities of Patodia Weaving Mills Private Limited (PWMPL). The rating continues to be flagged as "Issuer Not Co-operating" and is downgraded on account of information risk.

Maharashtra based Patodia Weaving Mills Private Limited (PWMPL) was incorporated in the year 2013 by Mahesh Kumar Patodia and family. It is engaged in the manufacturing of Jute Cloth and Jute Bags.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
