Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE double B minus**) and reaffirmed the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.42.25 crore bank facilities of Renite Vetrified LLP (RVL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Established in the year 2016, Renite Vetrified LLP (RVL), is a Gujarat based limited liability partnership firm. The firm is engaged in the manufacturing of glazed vitrified floor and wall tiles, nano and twin charged vitrified tiles. The firm is promoted by 17 partners with Mr. Paras D. Kavathiya, Mr.Dhirajlal K Suran and Mr. Jentilal B. Kavathi as the designated partners handing day to day operations of the firm. The manufacturing unit is located in Morbi-Gujarat, with an installed capacity of 73000 MTPA.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain.
