Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) on the Rs. 9.00 crore bank facilities of Sivana Steel And Power Private Limited (SSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on best available information.

About the Company

Sivana Steel And Power Private Limited (SSPL), a Chhattisgarh based company, was incorporated in the year 2017 by Mr. Ramesh Kumar Aggarwal, Mr. Neeraj Aggarwal and Mr. Gaurav Aggarwal. The company is mainly engaged in manufacturing of steel ingots with an installed capacity of 30000 Metric Tonnes (MT) per annum. The company is mostly supplying steel ingots to cold rolling steel plants and mills located in Chattishgarh and Uttar Pradesh.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
