Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 9.00 crore bank facilities of Sivana Steel And Power Private Limited (SSPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk .

About the Company

Sivana Steel And Power Private Limited (SSPL), a Chhattisgarh based company, was incorporated in the year 2017 by Mr. Ramesh Kumar Aggarwal, Mr. Neeraj Aggarwal and Mr. Gaurav Aggarwal. The company is mainly engaged in manufacturing of steel ingots with an installed capacity of 30000 Metric Tonnes (MT) per annum. The company is mostly supplying steel ingots to cold rolling steel plants and mills located in Chattishgarh and Uttar Pradesh.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
