Rating Rationale

Acuite has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE Double B minus**) on the Rs.12.00 crore bank facilities of Saraswati Trading Company. This rating is now an indicative rating and is based on best available information.

Based in Karnal, Haryana Saraswati Trading Company (STC) was established in 1992 as a partnership firm engaged in milling, exporting and supplying varied range of Basmati and Non-Basmati rice. The manufacturing facility is located in Karnal District -Haryana. The firm is promoted by Mr. Vishal Khanna, who looks after the day to day operations.

Non-cooperation by the issuer/borrower: Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
