Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE D**' (read as **ACUITE D**) on the Rs. 18.00 crore bank facilities of Siddhashram Rice Mills Cluster Private Limited (SRMCPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Siddhashram Rice Mills Cluster Private Limited (SRMCPL), was established in 2006 by Arun Kumar Mishra, Ajit Kumar Mishra and Brij Kumar Mishra. It is located in Buxar, Bihar. SRMCPL is a cluster project, engaged in the processing of par boiled rice varieties such as Mansoori and Kathani rice (Buddha Brand). It is also involved in renting of warehousing facilities (60,000sqft); and production of power from husk (it's by product).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
