Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE BB-' (read as ACUITE double B minus)** on Rs. 27.00 Cr bank facilities of Mangal Cotton Mills Private Limited (MC MPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

The Gujarat based company incorporated in 1979, Mangal Cotton Mills Private Limited (MCPL), erstwhile known as Rachana Fabrics Private Limited. The company has been engaged in providing machineries on rental basis used for laser multi drive computerized embroidery until February 2018. Further, from February 2018, the company has been doing dyeing, printing and embroidery on all kinds of cotton, polyester and blended fabrics. The company is promoted by Mr. Motilal Sekhani, Mr. Rinish Sekhani and Mr. Gunjan Sekhani.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain.
