Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.63 crore bank facilities of Precise Precision Machineries Private Limited (PPMPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Incorporated in 1978, Precitec Precision Machineries Private Limited (PPMPL), a Bangalore (Karnataka) based company, is engaged in manufacture of special purpose machine tools includes CNC machines for metal cutting. The company was promoted by Mr. H K Sridhara. Currently, the company is led by Mr. HS Nikhila and Mr. Ravindra Sridhara (sons).PPPL mainly caters to automobile, auto components, power generation and earthmoving equipment's sectors.

Non-cooperation by the issuer/borrower:
