Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE BB minus**) on the Rs. 10.00 crore bank facilities of Bharath Autos (BA). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

Bharath Autos is a Tamil Nadu-based partnership firm established by Mr. S. Bhoopathi and Mr. Durai Swami in 1998. The firm has been a dealer of TVS Motors for two-wheelers in Sullur and Palladam for more than two decades and has recently set up shop in Tirupur.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
