Acuité has reviewed long-term rating of '**ACUITE BB+**' (**read as ACUITE double B plus**) to the Rs.20.00 crore bank facilities of Dr. Kamakshi Memorial Hospital Private Limited. This rating is now an indicative rating and is based on best available information.

Dr. Kamakshi Memorial Hospital Private Limited (KMPL) was established in 2004 by Dr. T. G. Govindarajan. The company runs a 285-bed multi-specialty hospital located at Pallikaranai (Chennai) under the name 'Dr. Kamakshi Memorial Hospital'. The hospital was started as a dedicated centre for Cancer and Cardiac services. The hospital also offers a range of healthcare facilities in the fields of Cardiology, Diabetology, Nephrology, Medical Oncology, and Paediatrics among others.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.
