Rating Rationale

Acuite has reaffirmed the long-term rating of **‘ACUITE D’ (read as ACUITE D)** on the Rs. 12.60 crore bank facilities of Chopra Hotel and Resorts. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Chopra Hotel and Resorts (CHR) is a partnership firm established in 2013 by Mr. Kamal Chopra, Mr. Gaurav Chopra, Mr. Umesh Chopra and Mr. Ravish Chopra. The firm runs a hotel by the name of Ramada Encore in Jalandhar (Punjab) under a franchisee agreement with Wyndham Hotel Asia Pacific Co. Limited.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
