Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE D**’ (read as **ACUITE D**) and the short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs.200.30 crore bank facilities of Textrade International Limited (TIL). Also, Acuite has reaffirmed the long-term rating of ‘**ACUITE C**’ (read as **ACUITE Ca**) and the short-term rating of ‘**ACUITE A4**’ (read as **ACUITE A4**) on the Rs.24.70 crore bank facilities of Textrade International Limited (TIL). The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

The Gujarat based, Textrade International Limited (TIL), was incorporated in 2004 to take over the existing business of partnership firm which was established in 1984 by Mr. Bipin Doshi and Mr. Anish Doshi. The company is engaged in manufacturing of home textile products. The manufacturing unit is located in Surat (Gujarat). There are two more group companies apart from TIL viz. Textrade Inc. (WI) and Worldtex Manufacturing Private Limited (WMPL). TIL supplies mainly to the USA and European market.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuité’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity may be due to a result of deterioration in the credit risk profile of the entity. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
