Acuité has downgraded the short term rating to '**ACUITE A4** (Read as **ACUITE A4**)' from '**ACUITE A4+** (Read as **ACUITE A four plus**)' on the Rs. 6.00 crore bank facilities of RR Knitting and Sons (RRKS). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

RRKS, established in 2011, is a Tamil Nadu based partnership concern engaged in the manufacturing of knitted garments. The firm purchases yarn and converts the same into grey cloth. The firm outsources its dyeing work to R R Dyeing, a group firm.

The R R Group is a Tamil Nadu based group engaged in dyeing, printing of grey cloth and manufacturing of knitted garments. The group comprises three firms viz. R R Dyeing (RRD), R R Knitting & Sons (RRKS) and Fashion Knits (FK). The group exports majorly to Europe.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
