Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) on the Rs. 12.00 crore bank facilities of Prachee Polyfilms Private Limited (PPPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on best available information.

About the Company

Prachee Polyfilms Private Limited (PPPL), erstwhile known as Prachee Filaments Yarns Private Limited, was incorporated in 2009. Mr. Tejas Poddar and Mr. Rajesh Poddar are the promoters of the company. PPPL manufactures metalized films along with the colourized coating. These products find their use in the packaging and textile industry. The company has a manufacturing plant near Surat, Gujarat. The metalizing plant has an installed capacity of 250 tonnes per month and the coating plant has an installed capacity of 80 tonnes per month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain. Any rating with the suffix 'Issuer not cooperating' is assigned without any management interaction with the issuer entity or any data / information from the entity. Sometimes this non co-operation by a rated entity may be due to a result of deterioration in the credit risk profile of the entity.
