Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs.20.00 crore bank facilities of Surya Electricals and Engineers Private Limited (SEEPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Surya Electricals & Engineers Private Limited (SEEPL) was established in 1976 as a proprietorship firm and later converted to private limited in 2008. The Kolkata-based company is engaged in the manufacture of telecom towers. The company is also engaged in the fabrication of heavy structures such as columns, girders, truss, floor beam, insert plates among others and has installed capacity of 12,000 MT per annum. The company was promoted by the Kolkata-based Mr. Mimani and family.

Unsupported Rating

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
