Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 50.00 crore bank facilities of RVN Infra Private Limited. The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

About the Company

Incorporated in 2013, RVN Infra Private Limited is a Hyderabad based company engaged in civil construction activities comprising of construction irrigational canals, reservoirs, laying of railway tracks, bridges etc. The company is a registered special class contractor with Irrigation & CAD Department, Erramanzil- Hyderabad (Telangana). The company is promoted by Mr. R. Venkatramaiah who has experience of over four decades in the same line business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
