Acuité has downgraded the long term rating to '**ACUITE B+**' (read as **ACUITE B plus**) from '**ACUITE BB-**' (read as **ACUITE BB minus**) on the Rs. 11.00 Crore bank facilities of Shri Jothilingam Pattu Mahal Private Limited (SJPM). The rating continues to be flagged as "Issuer Not-Cooperating" and is downgraded on account of information risk.

SJPM was incorporated in 2006 by Mr. A. Senthilkumar and Mrs. Sarojadevi. SJPM is engaged in the retail sale of textile and different varieties of the readymade garment in Kovilpatti (Tamil Nadu). Mr. A Senthilkumar also operates a kid's retail garment store by the name 'Shri Jothilingam Kids Park' in Kovilpatti, and 'Shri jothilingam Pattu Mahal' in Sivagasi (Tamil Nadu) in partnership with other family members.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
