Rating Rationale

Acuite has downgraded the long-term rating to 'ACUITE B-' (read as ACUITE double B minus) from 'ACUITE B' (read as ACUITE B) on the Rs. 10.50 crore bank facilities of Global Technocrats Private Limited (GTPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Global Technocrats Private Limited (GTPL) was established in 1998 for manufacturing and installation of punched tape concertina coils, flat wrap weldmesh, spool plastic with punched tape and concertina flat wrap. The present directors of the company are Mr. Atul Aggarwal, Mr. Amrit Aggarwal and Ms. Monica Aggarwal. The manufacturing facility is located in Bhiwadi (Rajasthan). The products are supplied to various units of Border Security Force, CRPF, SSB and ITBP under the ministry of Home Affairs.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
